Proposal for Merch Requirements for Al-Wahda Sports Festival

The Islamic Shia Ithna-Asheri Jamaat of Toronto (ISIJ) is requesting quotations from vendors for promotional merchandise for the Al-Wahda Sports Festival hosted by the Islamic Shia Ithna-Asheri Jamaat of Toronto.

GENERAL TERMS AND CONDITIONS.

1. **ACCEPTANCE AND REJECTION:** The selection of the successful quote will be based upon responses received to the information and criteria included in the request for proposal and the proposed cost of merchandise. The ISIJ reserves the right to accept or reject any and all quotations and to waive any technicalities.
2. **DATE OF SUBMISSION:** All quotes must be submitted no later than **12:00pm on Wednesday, January 31st, 2024** via email to **secretariat@jaffari.org**.
3. **TIME FOR CONSIDERATION:** Unless otherwise indicated the offer shall be valid for 45 days from the date of bid opening. Preference may be given to bids allowing not less than 45 days for consideration and acceptance.
4. **INVOICES:** It is understood and agreed that orders will be shipped at the quoted prices to the Jaffari Community Centre, 9000 Bathurst Street, Thornhill, ON, L4J 8A7 and billed to the ISIJ of Toronto. Applicable tax shall be invoiced as a separate item.
5. **PAYMENT TERMS:** Payment terms are Net, 30 days after receipt of correct invoice or acceptance of goods, whichever is later.
6. **SAMPLES:** Samples of items, when required, must be furnished as stipulated herein, free of expense, and if not destroyed will, upon request, be returned at the bidder's expense. Request for the return of samples must be made within 10 days following opening of bids. Otherwise the samples will become ISIJ property. Each individual sample must be labeled with bidder's name and item number. Samples, on which an award is made, will be retained for the contract period. These will be returned, if requested, ten days prior to expiration of the contract.
7. **SPECIFICATIONS:** Any deviation from specifications indicated herein must be clearly pointed out; otherwise, it will be considered that items offered are in strict compliance with these specifications, and successful bidder will be held responsible to deliver the same. All item specifications, branding requirements, quantity requirements, delivery date and all other requirements are specified under Appendix A of this document.



8. AWARD OF CONTRACT: All qualified bids will be evaluated and acceptance made of the lowest and best bid most advantageous to the ISIJ as determined upon consideration of such factors as: prices offered; the quality of the articles offered; the general reputation and performance capabilities of the bidders; the substantial conformity with the specifications and other conditions set forth in the bid; the suitability of the articles for the intended use; the related services needed; the date or dates of delivery and performance; and such other factors deemed by the ISIJ to be pertinent or peculiar to the purchase in question. Unless otherwise specified, the organizing committee reserves the right to accept any items or groups of items on a multi-item bid. The ISIJ reserves the right to make partial, progressive or multiple awards: where it is advantageous to award separately by items; or where more than one supplier is needed to provide the contemplated requirements as to quantity, quality, delivery, service, geographical areas; other factors deemed by the ISIJ to be pertinent or peculiar to the purchase in question.

10. HOLD HARMLESS: Except as prohibited or otherwise limited by law, the vendor agrees to indemnify, save, and hold harmless the ISIJ, the organizing team and its officers, agents, and employees acting within the scope of their official duties against any liability, including costs and expenses, resulting from any negligent or willful acts or omissions by the vendor, or the officers, agents, employees, or the failure to perform or comply with any of the provisions of the offer.

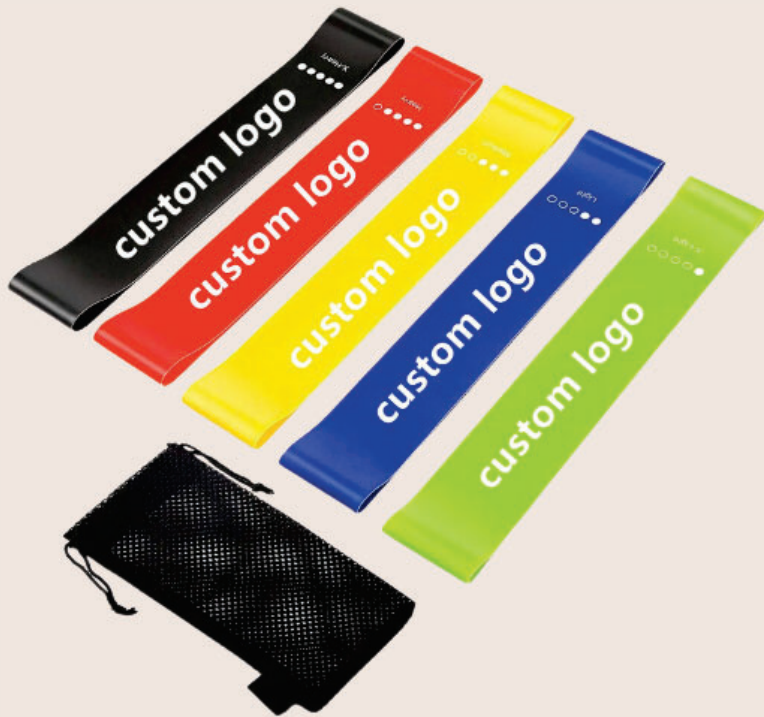
